## Director's Report

Bret Hitchings provided an update on the CTE funding formula. He will be working closely with the schools to verify that the proper course codes are being used and in some cases be recommending that CTE courses be modified based on the how the state funding formula is calculated based on the number of participants versus the number of concentrators.

Bret advised that Amanda will be sending Program Improvement information to each school district by the first week of October. Schools should expect to see a slight increase in funding from previous years due to an increase in Perkins funding for FY 26.

Bret informed that the Sophomore Tours, which counts as one of the two student Career Exploration Experiences for the CCPE, will be held November 3, 4, 5, and 6. Someone from HTA will be visiting each school prior to the tours with informational sessions for sophomores.

Bret advised that HTA and RCC will host the fall Counselor Academy. In the past this has usually been held the first week of November.

Meeting adjourned by Travis Roundcount at 9:28 a.m.




